Important Questions	Answers	Why This Matters:
What is the overall <b>deductible</b> ?	<b>\$2,000</b> /single or <b>\$4,000</b> /family. All <b>Providers</b> .	Generally, you must pay all of the costs from <b>providers</b> up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the policy, the overall family <b>deductible</b> must be met before the <b>plan</b> begins to pay.
Are there services covered before you meet your <b>deductible</b> ?	Yes. <b>Preventive care</b> for <b>Network Providers</b> .	This <b>plan</b> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply. For example, this <b>plan</b> covers certain preventive services without <b>cost-sharing</b> and before you meet your <b>deductible</b> . What is the <b>out-of-pocket limit</b> for this <b>plan</b> ?	<b>\$4,000</b> /single or <b>\$7,150</b> /family for <b>Network Providers</b> . <b>\$8,000</b> /single or <b>\$16,000</b> /family for Non- <b>Network Providers</b> .	The <b>out-of-pocket limit</b> is the most you could pay in a year for covered services. If you have other family members in this <b>plan</b> , the overall family <b>out-of-pocket limit</b> must be met.
What is not included in the <b>out-of-pocket limit</b> ?	Non- <b>Network</b> Transplant Services, <b>Premiums</b> , <b>balance-billing</b> charges, and health care this <b>plan</b> doesn't cover.	Even though you pay these expenses, they don't count toward the <b>out-of-pocket limit</b> .
Will you pay less if you use a <b>network provider</b> ?	Yes, Blue Preferred Select.
